<u>Landscape</u>: The board unanimously approved ProWay give a new proposal to replace all new Rail Road ties on the end units only. - 1. Asphalt Repair \$19,997 (Asphalt Doctors)
- 2. Soffit Repair \$42,881 (WDR Proposal)
- 3. Roof Replacement \$27,770 (SPCS Proposal)
- 4. Fence Repairs \$10,000 (Proposal not available)

<u>Loan:</u> The board requested the manager request loan options for capital improvements to include:

- 1. Soffit/Fascia Repair
- 2. Roof Replacement
- 3. Asphalt Repair/Replacement
- 4. Fencing

<u>Special Assessment:</u> The board discussed a special assessment to for the purposes of loan repayment for capital improvements. The manager recommended the use of approximately \$15,000 of reserve funds for the entire project. The capital improvement projects are

estimated at \$100,000. The board tabled the discussion until further information on the loan option
